Tournament Rules and Regulation for Team Events

1.The Motiram Cup, Late Shri Anant V. Ullal Cup and Kanji Memorial Interclub Badminton Tournament - will be open to all the Clubs, Gymkhanas from the Greater Mumbai District and Mumbai Suburban District with GMBA/ BAMU including Institutions clubs like Railways, Banks, ESIC, AG etc. registered with these District Associations.

2.Each Club, Gymkhana may field one or more teams, each consisting of not more than 6 players for the Motiram Cup and the Anant V. Ullal Cup and 8 players for Kanji Memorial Cup.

3.Normally, only bonafide permanent members of the Club/ Gymkhana are allowed to be included as players in respective teams. As a special dispensation three 'Playing member' per Team/ Event (of 6 month's standing i.e. Playing member before 1st October 2023) can be included in the Team/ Event from respective Club/ Gymkhana. However such 'Playing member' should produce respective Club/ Gymkhana's 'Playing Membership Card' and formal letter duly endorsed by the either the respective Club/ Gymkhana's President or Hon. Gen. Secretary stating that the grant of such playing membership has been formally approved and granted to the subject player at the Club / Gymkhana's Executive Council Meeting No. and Date.

4.The players (Permanent or Playing Member] representing the Clubs/ Gymkhana can however be residing and registered in other surrounding Districts of Grater Mumbai (GMBA) & Mumbai Suburban (BAMU) namely Thane, Palghar or Raigad Districts.

5.In Clubs such as or similar to Andheri Sports Complex , Kalidas (Mulund), MLWB, Balkanji Bari & Thakur Sports Club etc. the Players should prove their authenticity of membership by producing the respective Club's membership Card (more than 6 month old i.e. Member before 1st October 2023) and produce similar formal letter confirming membership duly endorsed by either the respective Club's authorised 'Administrative Officer (CEO/ Executive Officer) as the case may be.

6. In respect of Institutional Clubs like Railways, Banks, ESIC, AG Office etc. in addition to registered players from GMBA & BAMU the following are also Eligible to participate:-

a. Players under contract to play for any organization and residing in

Greater Mumbai, Mumbai Suburban, Thane, Raigad & Palghar.

b. Players from Railway and PSCB & Air India residing in Greater Mumbai,

Mumbai Suburban, Thane, Raigad & Palghar.

7. Only "BONAFIDE" members of six months standing shall be eligible to play for the club. No professionals shall be allowed to participate. Action will be taken against the players for giving wrong declaration. Coaching Academies will not be permitted to participate. All players are requested to carry the Club/ Gymkhana's Identity Cards during their ties and Age proof / Id cards during the course of the tournament.

8. Please fill in different forms in case your club/gymkhana has more than 1 team or if you wish to participate in different Event.

9. For Motiram Cup & Ullal Cup the teams can include only one player who has represented Senior State or participated in the Senior Nationals in the years 2021-22, 2022-23 & 2023-24. Further, such player is allowed to play only 1 match per tie. **The following players are considered as a State players – Chirag Shetty, Kaushal Dharmamer, Harsheel Dani, Shlok Ramchandran, Anand Pawar, Ajay Jayram, Firoz Mulani, Viprav Kuvale, Viraj Kuvale, Akshan Shetty Alisha Naik, Mehak Nayak, Anagha Karandikar. However, any other player falling under the above stated guideline who is residing in Mumbai, Mumbai Suburban, Thane, Palghar & Raigad or who has represented any other State at the Senior Nationals in last 3 years will also be considered as 'State player'.**

10. The tournament matches will normally be played either at the Willingdon Sports Club and the Bombay Gymkhana and if required on other Courts in the Greater Mumbai District and the Mumbai Suburban Districts and the Honorary Secretaries of the competing clubs shall have to make their courts available to the Tournament Committee if required for the competition.

11. Each tie for "Motiram Cup" and "Late Anant V. Ullal Cup" shall be decided by "Best of Three" matches consisting of two doubles and one single match. The order of play shall be a. 1st Double; b. Singles; c. 2nd Doubles.

12. Each tie for "Kanji Memorial Junior Interclub" will be decided by "Best of Five" matches. The order of play shall be as under –

a. Girls Singles (Under 15) Born on or After 1st January 2010;

b. Boys Singles (Under 15) Born on or After 1st January 2010;

c. Mixed Doubles (Under 19) Born on or After 1st January 2006;

d. Boys Doubles (Under 19) Born on or After 1st January 2006;

e. Girls Doubles (Under 19) Born on or After 1st January 2006.

13. The captain of each team shall nominate singles player and doubles pair at least 15 minutes before the time fixed for the commencement of the tie.

14.No matches will be played after a team has obtained a wining lead

15. The challenge Cup Trophy will not be won outright but will be held by the wining club for a maximum period of one month. If so desired the possession of the challenge cup will be given to the Hon. Secretary of the club concerned and the club should undertake to return the cup one month before the due date of the next tournament and should guarantee to make good the loss or damage to the cup. The committee may give a replica or any other prize to the wining club as Memento.

16.The laws of Badminton shall apply.

17.In all the matters of dispute the decision of the Tournament Committee shall be final will be binding on all competitors.


18.The committee reserves the right to refuse any entry without assigning any reason whatsoever.

19.If the name of any player is found in more than one team, the tournament committee shall be the sole judge to decide his / her participation for any of the event.

20. Junior players participating in the Kanji Cup can also participate in the Motiram/Ullal Cup from another club/Gymkhana.
